1.2 Current confirmation status

Krajowa Izba Rozliczeniowa S.A. is a qualified trust service provider (qTSP) according to Art. 24 of the eIDAS Regulation².

The last full conformity assessment was accomplished with issuing the conformity certificate T-Systems.031.0257.06.2017 as of 01.07.2017. It was based on the TSP Certification Policy version 1.0 as of 28.04.2017.

The first re-assessment of conformity was performed and documented under ID T-Systems.031.0257.U.09.2017.

The current Attachment No. 2 to Certificate T-Systems.031.0257.06.2017 serves the continuation of the status as a 'qualified trust service provider' according to Art. 24 of the eIDAS Regulation for all qualified trust services offered by the qTSP in the eIDAS context.

The current conformity assessment is based on same version 1.0 as of 28.04.2017 of the TSP Certification Policy and is performed in accordance with Article 20(1) of the eIDAS Regulation.
